

**PROMOTION TERMS AND CONDITIONS
OUT OF THIS WOLD PROMOTION
SAMSUNG ELECTRONICS (UK) LIMITED**

Participants agree to be bound by these terms and conditions (the “**Terms and Conditions**”). Any information or instructions published by the Promoter about the Promotion at <https://www.samsung.com/uk/outofthisworld> form part of the Terms and Conditions.

The Promoter

1. The Promoter is Samsung Electronics (UK) Limited, Samsung House, 1000 Hillswood Drive, Chertsey, Surrey, KT16 0PS (the “**Promoter**”).

Purchase Period

2. The Promotion will commence at 00:01 (BST) on 11 September 2019 and shall close at 23:59 (GMT) on 5 November 2019 (the “**Purchase Period**”).

Eligibility

3. To be eligible to participate in the Promotion you must be a Great Britain, Channel Islands or Isle of Man resident aged 18+ with a valid bank account (“**Participant**”).
4. This Promotion is only available to end users (e.g. not to any reseller or business) and is not available in conjunction with any other offer.
5. Rewards shall be paid by way of bank transfer and Participants must have a valid UK, Channel Islands or Isle of Man bank account in order to receive the Reward.

Offer

6. Participants of Great Britain, Channel Islands or Isle of Man who purchase a Promotion Television (either as part of the Cashback Promotion or separately) within the Purchase Period and from a Participating Retailer and go on to make a valid Claim (as defined at Condition 14 below) shall be entered into a prize draw (“**Entry**”) whereby each Entry shall have a chance to win a holiday with a value of either £2,000, £4,000, £8,000 or £10,000, from a selection of different locations and dates as shown [HERE](#) (“**Prize**”), dependant on the specific purchased Promotion Television as shown at Table 1 below, subject to full compliance with these Promotion Terms and Conditions (“**Prize Draw Promotion**”).
7. All Participants taking part in the Prize Draw Promotion (i.e. those who make a valid Claim as defined at Condition 14 below) shall also receive ten individual (10) movie rentals (“**Gift**”) redeemable at www.rakuten.tv/uk subject to the relevant terms and conditions available at https://rakuten.tv/uk/terms_conditions/982, (“**Gift Terms and Conditions**”) provided via the email address given during the Claim process (“**Gift with Purchase Promotion**”). Further details of the Gift are provided at Condition 10 below.
8. In addition, Participants who purchase a selected new (i.e. not refurbished or second hand) Samsung television (“**Promotion Television**”) as detailed in Table 1 below and a selected new Samsung soundbar (“**Promotion Soundbar**”) as detailed in Table 2 below (together the “**Promotion Products**”) (either within the same transaction or within 30 days after the date of purchase of the Promotion Television) from the same Participating Retailer (as defined at Condition 12) within the Purchase Period will be eligible to claim a cashback reward, equivalent to 50% of the purchase price of the Promotion Soundbar as stated on the relevant proof of purchase, up to a maximum of 50% of the RRP of the relevant Promotion Soundbar (“**Reward**”) subject to full compliance with these Promotion Terms and Conditions (“**Cashback Promotion**”).

9. For the avoidance of doubt, all Entries have the same chance of winning any Prize in their respective Category.
10. Each Gift shall entitle the Participant to ten (10) individual movie rental vouchers (“**Rental**”) via www.rakuten.tv/uk. Participants must have a valid Rakuten account in accordance with the Gift Terms and Conditions in order to redeem the Gift via Rakuten TV app on a Samsung UHD smart TV device. Each Rental may be redeemed against any movie listed on the service as a rental with a rental value between £4.99 - £5.49. For the avoidance of doubt Participants may not combine multiple Rentals to rent a movie with a higher rental value, nor can the value of each Rental be used to permanently purchase any movies or other content on the service. All Rentals must be made before the 31st March 2020, after which they will expire and will no longer be considered valid.
11. Participants may make one Claim per Promotion Television purchased under the Prize Promotion. Participants shall also be entitled to one Gift per Promotion Television purchased under the Gift with Purchase Promotion. Under the Cashback Promotion Participants may make one Claim per Promotion Television and Promotion Soundbar purchased.

12. For the avoidance of doubt Participants who purchase both a Promotion Television and Promotion Soundbar may take part in both the Cashback Promotion and Prize Draw Promotion and must make separate Claims within both Promotions. Participants who only purchase a Promotion Television may accordingly take part in the Prize Draw Promotion only and must make a Claim to enter.
13. To be eligible under the Promotion, purchases of Promotion Products must be made from either Dixons (Including Currys PC World), Richer Sounds, Sevenoaks, John Lewis, AO, Shop Direct, Freemans, JD Williams, Hughes, Samsung Shop Online, Euronics Group members, Soloco Group members, CIH Group members or any retailer listed HERE ("**Participating Retailer**").

Claims

14. After purchasing a Promotion Product(s) from a Participating Retailer during the Promotion Period, Participants who wish to take part in any of the Promotions must visit www.samsungpromotions.claims/outofthisworld and complete the presented claim form with their name, contact information, bank account details and any other requested information (which may include a photograph of the serial number of the purchased Promotion Product(s), and submit it together with a scanned copy of their proof of purchase (a "**Claim**"). For the avoidance of doubt, Participants taking part (i.e. making a valid Claim) in the Cashback Promotion will automatically be entered into the Prize Draw Promotion and in turn the Gift with Purchase Promotion. Participants who purchase a Promotion Television in a separate transaction from a Promotion Soundbar (or do not purchase a Promotion Soundbar) will need to make a Claim under the Prize Draw Promotion. If the Participant later purchases a Promotion Soundbar in accordance with Condition 8 above, the Participant must make a separate Claim under the Cashback Promotion.
15. Claims may only be submitted between zero (0) and thirty (30) days after the date of purchase of a Promotion Television, meaning the final Claim date (for all Promotions) for purchases made on 5th November 2019 is no later than 23:59 (GMT) on the 4th December 2019. Claims outside of this period will not be eligible for either a Gift, Prize or Reward (as applicable). For the avoidance of doubt, the date of purchase of the Promotion Television counts as day one (1).
16. Participants will be sent an email and SMS to confirm that their Claim(s) has been received by the Promoter and that it has been successful and validated ("**Claim Validation**").
17. If an email or SMS acknowledgement has not been received, it is the Participant's responsibility to contact the Promoter's customer service team at outofthisworld@samsungpromotions.claims or 03452160132 within seven (7) days of a Claim being submitted.
18. If any Claim is deemed to have not been submitted correctly, the Participant will be notified via email and SMS and offered the opportunity to provide the required information to validate their Claim within seven (7) days. If no response is received, then the Claim shall be marked as invalid and the Participant will no longer be eligible to receive the Reward and/or Gift or be deemed to have entered the Prize Draw Promotion.
19. Subject to passing any further audit undertaken at the discretion of the Promoter, Participants will receive the Reward by way of bank transfer to the bank account detailed in the Claim within thirty (30) days of Claim Validation.
20. Participants shall receive the Gift by way of email to the address provided within the Claim Process within thirty (30) days of Claim Validation.
21. Participants who are selected to receive the Prize in the Prize Draw Promotion ("**Winning Participants**") shall receive notification of such and instruction on how to select their chosen Prize by the 18th December 2019. Winning Participants shall be selected at random from all Entries received in each Category as

referenced in Condition 9 above. Prizes shall be managed by an ATOL approved agency (“**Travel Agency**”) and are governed by the separate terms available HERE which will vary on the specific Prize selected by a Winning Participant. The Promoter takes no responsibility for the booking or other provision of the prize, which shall be the sole responsibility of the Travel Agency.

22. Claims that are incomplete or damaged will be deemed invalid. No responsibility is accepted by the Promoter for lost, delayed or damaged data which occurs during any communication or transmission of Claims.
23. The Promoter reserves the right at its absolute discretion to disqualify Claims which it considers do not comply with these Terms and Conditions.
24. The Promoter shall have the right, where necessary, to undertake all such action as is reasonable to protect itself against fraudulent or invalid Claims including, without limitation, to generate or require further verification as to proof of purchase, as well as the identity, age, and other relevant details of a Participant. This process may involve the Promoter sharing information with third parties.
25. If a Participant returns a Promotion Product after making a Claim, then the Participating Retailer shall notify the Promoter and the Claim shall be rejected and any relevant Entry considered invalid. Where the Reward or Prize has already been paid/then the Promoter shall seek to recover the Reward or Prize from the Participant which where necessary may involve legal action being carried out against the Participant.
26. A Claim must be made by the Participant, and must not be made through agents, third parties or in bulk.

Privacy and Data Protection

27. Other than as set out in these Terms and Conditions or for the purposes of operating the Promotion, the details and information provided by the Participant when entering the Promotion or claiming the Reward/Prize will not be used for any promotional purpose, nor shall they be passed to any third party.
28. The Participant may withdraw consent to such use of personal information by writing to the Promoter or by using the opt-out process outlined in the Promoter’s privacy policy, available at www.samsung.com/uk/info/privacy.

General

29. The Promoter shall not be liable for any interruption to the Promotion whether due to force majeure or other factors beyond the Promoter’s control.
30. The Promoter reserves the right, acting reasonably and in accordance with all relevant legislation and codes of practice, to vary the Terms and Conditions of the Promotion.
31. Rewards and Prizes are non-transferable and not redeemable for cash by Participants.
32. The Promoter will not be responsible or liable for: (a) any failure to receive submissions due to transmission failures and other conditions beyond its reasonable control; (b) any late, lost, misrouted, or damaged transmissions or claims; (c) any computer or communications related malfunctions or failures; (d) any disruptions, losses or damages caused by events beyond the control of the Promoter; or (e) any printing or typographical errors in any materials associated with the Promotion.
33. Participants will be solely responsible for any and all applicable taxes and any other relevant costs or expenses which are not stated in the Terms and Conditions as included in the Reward or Prize.
34. By participating in this Promotion, you agree, to the maximum extent permitted by applicable laws, to release and hold the Promoter harmless from any and all liability whatsoever for any injuries, losses or damages of any kind arising from participation in or in connection with the Promotion, including without limitation, awarding, acceptance or receipt of the Reward/Prize. The above limitation of liability shall not apply to death or personal injury caused as a result of Promoter’s negligence.
35. The Promotion is governed by English law.
